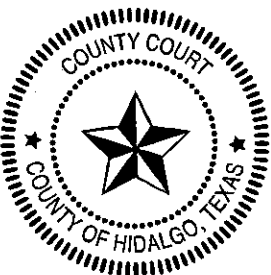

THIS SECOND SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SOÑADOR TRAILS SUBDIVISION (this "Second Supplemental Declaration") is made this 17 day of November, 2021, by **ESPERANZA HOMES EDINBURG, LLC, a Texas limited liability company** (hereinafter referred to as "Declarant").

WITNESSETH:

WHEREAS, Declarant is the owner of the real property described on **Exhibit "A"** attached hereto ("Soñador Coves Phase II") and made a part hereof for all purposes, and desires to create thereon a residential community with residential lots, open spaces, landscaping, streets, common lighting, and other common improvements for the benefit of the community;

WHEREAS, Declarant is the owner of real property located near Soñador Coves Phase II that is subject to a Declaration of Covenants, Conditions and Restrictions recorded on February 12, 2020 under Document No. 3088727, in the Official Records of Hidalgo County, Texas (the "Declaration");

WHEREAS, the Declaration was supplemented by instrument recorded December 10, 2020 under Document No. 3174484, in the Official Records of Hidalgo County, Texas, to annex additional real property;

WHEREAS, Article Eight, Section 8.05 of the Declaration provides that Declarant may "add or annex additional real property...to the scheme of this Declaration by filing of record a Supplemental Declaration of Restrictive Covenants...which shall extend the scheme of the covenants of this Declaration to such property"; and


WHEREAS, Declarant desires to annex Soñador Coves Phase II and extend the scheme of the Covenants and Restrictions of the Declaration to Soñador Coves Phase II by adopting and recording this Supplemental Declaration.

NOW, THEREFORE, Declarant declares that Soñador Coves Phase II is and shall be held, transferred, sold, conveyed and occupied subject to the covenants, conditions, restrictions, easements, charges and liens set forth in the Declaration.
